## **Budget Update: Innovation Fund**

Julie introduced unexpected surplus money of \$8,000 discovered in Sept and placed in this Innovation Fund to determine how to spend later (see attachment for \$ amount allocated to each line item below)

Recommendation to support the remaining budget requests council received in June and had to turn down because we didn't have the money then:

- 1. **Technology** (laptop replacement, screens, ipads, 2 desktop computers in every homeroom). Julie moves that we increase, Jennifer Haines 2<sup>nd</sup>, executive voted <u>in favour</u>
- 2. **Kindie-Capital Improvement** to go towards asphalt yard enhancements. Julie moves that we move ahead with this endeavor and Matt 2<sup>nd</sup>, executive voted in favour
- 3. **My Life Online** shows kids how to be safe on-line for grades 4-6 plus parent presentation determined to shelve this item for now in case we use Telus free offer instead.
- 4. **Integrated Arts Capital Support** towards Mr. Mason's required speaker upgrade. Julie moves that we move ahead with this item and Lisa 2<sup>nd</sup>, executive voted <u>in favour</u>.
- 5. **Grade 6 Legacy Art Project** increase in grade 6 student number to 68. Julie moves we increase budget to support all students and Jeny 2<sup>nd</sup>, executive voted <u>in favour</u>.
